## Chapter-2 (Manual -1)

# PARTICULAR OF ORGANIZATION, FUNCTIONS AND DUTIES

### 2.1 Objective/purpose of the public authority.

PWD Division No 1<sup>st</sup> (I&FC) Division Kargil has been the biggest inspiring force of the Ladakh Autonomous hill Development Council in alleviating poverty in rural areas since its inception. The main aim of this division is to construct the irrigation khul/ canals for the barren land to cultivable so that the poor agriculturist could be improved their socioeconomic growth on grass root level. This division construct the protection bund along the Rivers of the District so that the cultivable land and plantation situated beneath the banks could be saved during the peak season of the discharge in the rivers as well as unanticipated floods.

### 2.2 Mission/vision statement of the public authority

### **Vision Statement**

To growup the irrigation sector and develop the command area of the district. The people who are dependable on agriculture could be financially growup. While at the same time giving due emphasis to framing the lift irrigation project and gravity system irrigation project.

### 2.3 Brief history of the public authority

The Division was created/ sanctioned by the Government in the year <u>1982 - 83</u> naming it as **PWD Division No Ist, (Irrigation & Flood Control) Kargil**. The main aim of the Division is to execute/ supervise all the irrigation and flood control related works of District Kargil except Zanskar Division as proposed by the Government.

# 2.4 Duties of the public authority The duties of the Institute involve functioning as:

- To prepare the plans and implement works under various schemes
- To make irrigation project under various schemes/programme
- To floating tender for construction of khul, canals and protection bund
- To inspect the executing works concerned the division.

### 2.5 Main activities/ functions of the public authority

- To Implement various scheme for constructing the khul, canal and protection bunds to redressal the public grievance
- To Implement other schemes of the Government like BADP, TSP
- To implement the works assigned under various Local Area Development Funds like MPLAD, MLA/MLC LAD, CCDF.
- To implement works under the District plan
- To implement Central Sponsored scheme, such as, AIBP, NABARD, STF and FMP for construction of Medium, Minor irrigation schemes and Flood protection works.

# 2.6 List of services being provided by the public authority with a brief write ups on them.

### **Central Government Schemes:**

**A.I.B.P.** (Accelerated Irrigation Benefit Programme): One Major/ Medium irrigation canal namely Parkachik Khows irrigation canal is executing under AIBP programme. Under this programme the funds released on matching share i.e. 90% investment from central government as Central Assistance and 10% investment from state government as State share.

There are many minor irrigation project has been approved under AIBP with the different TACs, such as 8th, 9th, 10th, 11th, and 12th TACs. The State Government has framed a Technical Advisory Committee for examine the project after that the projects send to Central Government for further course of action. The division has taken in hand the projects after sanction of approval from the government. The central monitoring teams are visiting from time to time for inspection of the projects.

**NABARD (National Bank of Agriculture and Rural Development)**: NABARD Loan assistance to district Kargil are sanctioned providing loan assistance to construction of various irrigation schemes/ canals to boost the agriculture production like alpha alpha, vegetables, ballies, fruit trees etc.

**BADP (Border Area Development Programme):** A special allocation is given to all the blocks bordering other countries so that the border areas develop at par with the other areas of the country. Kargil District has Three blocks of Drass, Kargil, Shakar Chiktan which share the same border with Pakistan (BADP Indo-Pak).

**CDF (Community Development Fund):** In Kargil District the Community development funds of One Member Parliament, two member legislative Assemble, one member legislative Council, and 30 councillors allocate their community development funds for various developmental works. At an average 10% of the community development works are assigned to PWD Division No Ist Kargil for execution and remodeling the existing zamindari khuls.

**District Plan**: 90% of zamindari khuls was entrusted to Rural development Department of District Kargil but the major irrigation zamindari khul which are beyond the capacity of Rural Department are entrusted to identified by Councillor for strengthen and remoulding of khuls was entrusted to I&FC Division Kargil for which meager amount of allocation was proposed under District Plan.

**S.T.F Special Task Force:** A team of members by central Governemtn was visited to Ladakh region for redress the grievance of the area and they reflected the schemes which was of important nature to providing connectivity to the rural area by constructed bridges, and promoting education byway of upgrading the intrusting of the district Kargil including boosting agriculture byway of protecting the land by way of anti erosion control keeping the fact that megar lands are available along the river like Suru and Drass River for which funds were made available for these schemes and also lift scheme to drought prone area of Soudth.

**FMP (Flood Management Programme):** For protecting the lands near River and nallahs Government of India sanction funds for flood management programme after devastating floods in Leh and Kargil in the year 2010.

# 2.8 Expectation of the public authority from the public for Enhancing its effectiveness and efficiency:

To the general public is expected to remodeling/ restoration their zamindari khuls and construction of canal for their possessed barren land

- 3. He is over all incharge of execution of works at site including implementation of quality control and maintenance of specification.

## **Junior Engineer:**

#### **Duties:-**

- 1. To prepare proposals/ estimate and conducting survey to submit the Divisional office for further course of action.
- 2. He is incharge of civil works of his section.
- 3. He is submitting the work done claims
- 4. providing Guidance to work supervisor.

## **Work Supervisor:**

### **Duties:-**

- 1. To supervisor the all executing works byway of maintaining quality control and specification.
- 2. He will submit the report to Asstt. Engineer and Jr. Engineer for day to day progress of executed work.
